Action Title: NANOSCALE COHERENT HYBRID DEVICES FOR SUPERCONDUCTING QUANTUM TECHNOLOGIES

**Minutes Management Committee Meeting GP4
21st of December 2020 (Remote meeting - via Zoom)**

1. Welcome to participants

The meeting starts at 10h00. The Chair of the Action, Hermann Suderow opens the meeting and welcomes all participants. This is an exceptional online MC meeting forced by the confinement circumstances affecting all European countries due to the coronavirus outbreak.

The reason for organizing this 3rd online meeting shortly after the previous online meeting held on the 6th of November 2020 is that few days after the meeting, a letter from the COST Director was received by the Action Chair informing that the Grant Period has been elapsed until the 17 October 2021 (almost 6 months). Therefore, a new MC meeting is needed to organize the Grant Period Activities taking this new situation into account.

2. Verification of the presence of two-thirds of the Participating COST Countries or, if applicable, a quorum

32 participants are present in the meeting. More than 2/3 of the country representatives of the Action attended this 6th Management Committee meeting. Therefore, the quorum was achieved. The decisions taken during the meeting and the issues discussed are reported in these minutes and will be sent to all MC members for approval.

3. Adoption of agenda

The meeting participants agreed to adopt the meeting agenda sent by the Action Grant Holder via email on the 17th of December, 2020, where the main points for discussion were also highlighted.

There were no pending issues from last meeting.

4. Update from the Action Chair and Grant Holder

- a) **Status of Action:** Start and end dates of Action. Information about recent discussion with the Scientific officer: Possibility to extend the project duration by 6 months (until April, 2022). Formal request will be sent in February 2021. Decision will be taken by March 2021. The current Grant Period has been elapsed until the 17 October 2021 (almost 6 months). Therefore, a new MC meeting is needed to organize the Grant Period Activities taking this new situation into account.

b) Action budget status

After discussion with the scientific officer at COST, the Chair informs that:

- To minimize the risk for underspending in this grant period due to the absence of large in-person meetings, the current GP has been extended by almost 6 months, from the 30th of April 2021 until the 17th of October, 2021
- Not just remote, but also budgeted activities are needed to guarantee enough support from COST to end the Action, once in-person meetings become possible again after the pandemic.
- The Action will be extended at most for six months, thus until April 2022. The proposal should be submitted to COST by March 2021.

Several MC members comment on these issues.

Following the discussion, the Chair proposes:

- That the next meeting shall be organized in summer in Slovakia, as planned. The most probable situation of the pandemics will likely force the celebration of a hybrid meeting, with Slovakian and close-by colleagues attending the meeting and others joining online. Local organizers agree with this proposal. Final dates will be communicated in the following weeks/months (Initial date proposed is the week of the 28th of June)
- That we make extensive use of STSM, as this instrument is not so touched by the pandemics, given that it is an individual action.
- That we open the possibility that the Action funds open access (OA) publications. The OA committee members (Annica Black-Schaffer, Chual Li, Simon Bending and Szabolcs Csonka) will select the publications to be funded, based on the achievement of the objectives of the Action.
- That we promote remote meetings as far as possible.

The proposals are accepted by the MC.

c) Short Term Scientific Missions (STSM) and ITC conference Grants: review of completed reports and new applications

The STSM committee has granted two STSMs during this period, one to a female going to Madrid, one of a male going to Sweden. The discussion about promoting the STSM continues and the MC agrees to promote the use of this instrument as far as possible. The Chair acknowledges the work of the STSM committee.

Regarding the ITC conference grants, in the previous online meeting, the question was raised by Pertti Hakonen whether registration fees to an online conference could be considered within the ITC grant scheme. Examination of the COST Vademecum after the meeting provided the answer to the question about funding for registration fees of remote meetings, see <https://www.cost.eu/wp-content/uploads/2020/06/Vademecum-V8-1-May-20202.pdf>, page 33, within the ITC grant scheme, "Up to a maximum of EUR 500 can be claimed for the conference fees to be incurred by the selected Grantee. Virtual conference fees can be considered eligible provided all other eligibility conditions are fulfilled."

d) Dissemination actions – Open Access Publications

A discussion starts about Open Access Publications. It is reminded that the COST requires that at least 3 members (=countries) should be on the author list to fund Open Access Publication. Some participants ask the question about publications ensued from STSM. In that case, usually only 2 partners will be involved. Such publications would really make sense in the framework of the Action, more than publications obtained within usual collaborations. The participants ask the Chair and Grant Holder to transmit a request to our COST Science Officer to consider rethinking the conditions and facilitate, as much as possible, the inclusion of publications that are the outcome of a STSM.

5. Implementation of COST policies on:

- a) Promotion of gender balance and Early Career Investigators (ECI)**
- b) Inclusiveness and Excellence (see below list of Inclusiveness Target Countries)**

The Chair remarks the need to monitor carefully the gender balance and early career investigators support of the Action. The Chair informs about the outcome in the STSM of this period. Further discussion will be made in the next meeting.

6. Follow-up of MoU objectives: progress report of working groups

The Chair reminded the Action objectives and WGs based on the Memorandum of Understanding as well as the management structure.

7. Scientific planning

a) Scientific strategy

a.1) Next Action. The participants agree to prepare a new proposal for a new Action in the next collection date of COST. Currently discussions are being held regarding the new Horizon Europe programme, budget negotiations, etc. New calls will likely be launched in Spring 2021. Then specific actions can be arranged.

The possibility of requesting a COST Innovation Grant (<https://www.cost.eu/wp-content/uploads/2019/11/COST-060-19-CIG-Guidelines.pdf>) is discussed. Jan Aarts mentions about the "Physics meets industry" currently organized in the Netherlands (e.g. <https://www.lorentzcenter.nl/physics-with-industry-2020.html>), which are in line with this idea. Peter Sørensen comments on the European

Study Groups for Industry (ESGI <https://ecmiindmath.org/category/esgi/>). This possibility will be discussed again during the MC meeting in February/March 2021.

a.2) Book of the Action. Publishing a book is also a very interesting activity that will serve to compile and report many of the results of the action, and which will therefore contribute to leverage its impact. The Chair and Vice-chair of the Action will discuss about how to structure and organize it and will present the outcomes of these initial discussions to the rest of the members in the forthcoming MC meeting for further details.

a.3) Remote meetings. Initial discussions were held during the summer between some partners to organize webinars. J. Aarts mentions the need to have more meetings, so that young participants can present their results. A proposal for several half-day meetings will be forwarded soon to the MC by the Chair of the Action. The Chair reminds that this would only be an interim solution as the motivation of COST should be based on the in-person contact between researchers.

b) Long-term planning (including anticipated locations and dates of future activities)

Activities other than STSMs and the June meeting in Slovakia will be debated during the MC meeting in February/March 2021. A call for proposals will be disseminated among the MC members.

c) Dissemination planning (Publications and outreach activities).

The Chair reminds that publications acknowledging the Action are referenced in the webpage of the Action.

8. AOB

Main themes for discussion were risen in previous points.

9. Location and date of next meeting

The next online MC meeting will be held in February/March 2021 once the issues about the extension of the duration of the action as well as on the possibility to carry-over the unspent budget of the period are clearer.

The next physical or hybrid MC meeting will be held during the meeting in Slovakia in June 2021.

10. Closing

The MC Chair thanked the participation of all the MC members and closed the MC meeting at around 11h30.
